- VII. Presidents Report Diana Ogimachi, report provided in packet. Diana touched briefly on each item.
  - a. Updates
    - i. About 35% of classes will re-open in fall. Dr. Munoz does not want to lose students to surrounding colleges that may offer larger number of classes in-person.
    - ii. There will be study spaces on campus: Nordic Lounge at LAC and GG238 at PCC. Students need to bring their own laptops.
    - iii. Computer labs will be opening May 3, 2021.
    - iv. Limited cashier, admissions, and financial aid hours.
    - v. The District is doing an ongoing student survey and have had over 3800 responses at this time.
      - 1. Half of responding students are not comfortable returning to campus, the other half is looking forward to returning.
